
- The THE TELANGANA FRANSALIAN SOCIETY IS A registered Society under the Andhra Pradesh Society Registration Act. 2001.



- That the School will not open classes under CBSE pattern particularly class IX/X/XI/XII until affiliation is obtained.
- 7. That the principal and Correspondent of the school have individually gone through the provisions contained in the affiliation & examination bylaws gone the circulars issued by the Board from time to time.
